The scholarship winners will be selected by random drawing. Winners do not need to be present for drawing. The two winners will be notified by Friday, April 12th.

#### **Eligibility Requirements**

You must meet the following requirements to be eligible for this educational assistance program:

- Currently accepted at an accredited university, college, community college or recognized vocational school.
- Applicants must have a Checking and Savings Account with CES Credit Union and be in good standing.

IMPORTANT NOTE: Past winners and the immediate family of CES Credit Union employees and directors are ineligible for this contest.
